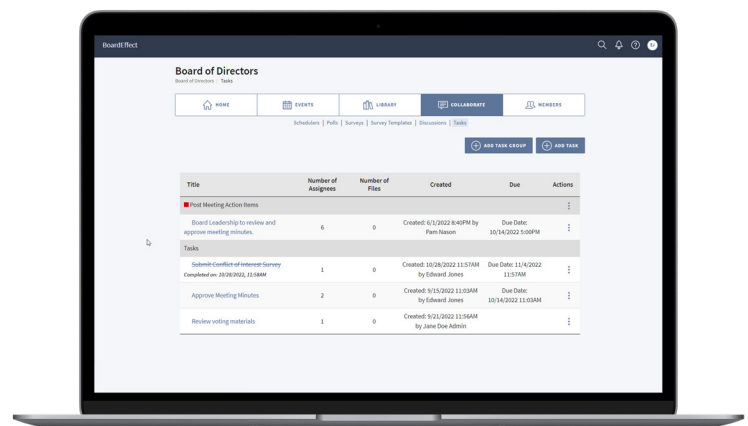

Maximise meeting time

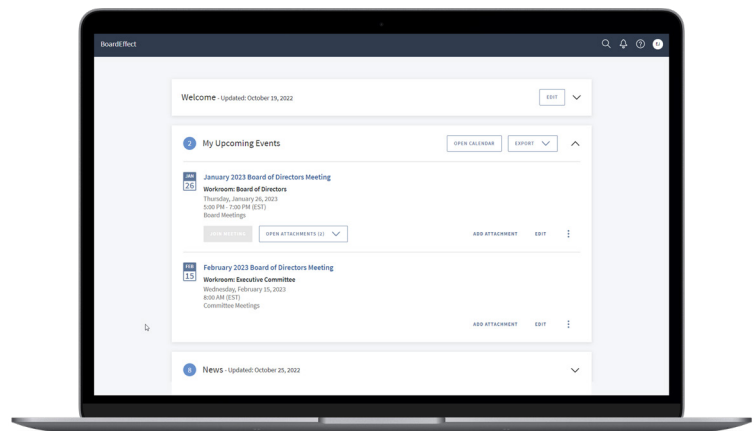
Time is of the essence and every minute counts during a board meeting.

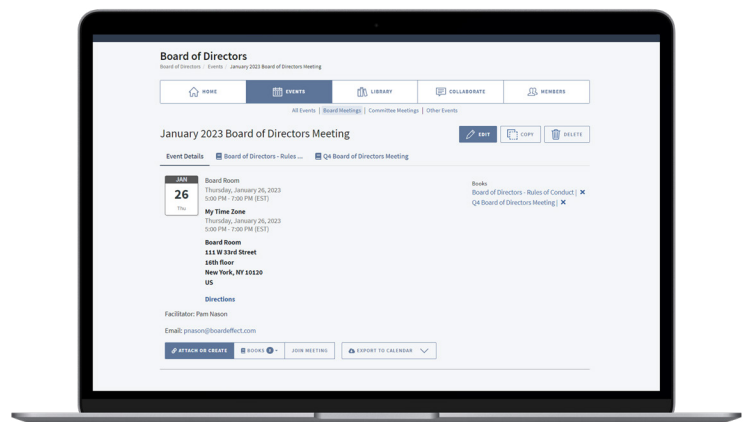

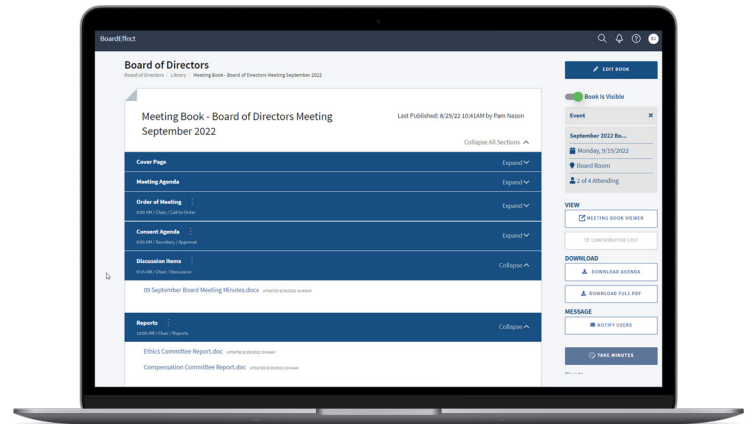
